विषय/Sub: Liberalised Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD)

- 1.0 In terms of Board's letter of even number dated 26.03.2024 (Rates Circular under reference), guidelines were issued on the above cited subject w.e.f 01.04.2024 and is valid till 31.03.2025.
- 2.0 The matter has been reviewed. Sanction of the Competent Authority is hereby accorded for addition and deletion of certain traditional empty flow streams in the policy, which are annexed with this circular.
- 3.0 All other details of the policy will remain unchanged.
- 4.0 These instructions will come into force w.e.f 29.04.2024 and will remain valid till 31.03.2025.
- 5.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate in the Ministry of Railways.
