विषय/Sub: Facility for cancellation of already registered indent through e-RD module.

Requests have been received to permit customers to cancel already registered indent through e-RD module.

Extant guidelines regarding registration of indent, allotment and supply of wagons are prescribed vide Rule 201 of Chapter-II of Goods Tariff Part-I (Vol.-1). Guidelines for registration of demand for wagons electronically (e-RD) are prescribed vide Rates Master Circular/e-RD/2019/0 and amendment thereto.

The matter has been examined and it has been decided to allow customers to cancel already registered indent through e-RD module, by inserting additional Para 7.8 in Rates Master Circular/e-RD/2019/0, as under:

"7.8: Provision for cancellation of already registered indent

In case of indents placed through e-RD module, customers will be given the facility for cancellation of already registered indent through e-RD module. This facility will be optional. It will be applicable to all types of freight customers and all kinds of freight terminals (viz. Goods Sheds, sidings, PFTs, GCTs etc.).

The guidelines regarding forfeiture of Wagon Registration Fee as per Para 201(15) of Chapter-II of Goods Tariff Part-I (Vol.-I) should be followed. Copy of the same is enclosed herewith."


CRIS/FOIS will develop the requisite facility in the system, duly keeping in view the extant guidelines.

These guidelines will be effective from 01.06.2024.

In order to review the efficacy of the aforesaid facility, Zonal Railways will furnish its feedback after one year of its operation.

This issues in consultation with Traffic Transportation directorate and with the concurrence of Finance directorate of Railway Board.
