- 1.0 The charging of automobile traffic carried in NMG group/BCCNR and BCACM wagons are governed by Rates Circular No.32 of 2021 and corrigenda thereto.
- 2.0 The present freight rates for automobile traffic when carried in NMG group/ BCCNR and BCACM wagons were notified vide Corrigendum No. 4 & 5 of Rates Circular No.32 of 2021 and are valid till
- 3.0 The matter has been reviewed and it has been decided to revise the present freight rates applicable for transportation of automobile traffic in NMG group/BCCNR and BCACM wagons. Revised freight rates are enclosed as Annexure.
- 4.0 All other terms and conditions stipulated in Rates Circular No.32 of 2021 and corrigenda thereto will continue to apply unchanged.
- 5.0 These instructions shall come into force w.e.f. 01.07.2024 and shall remain valid till further advice.
- 6.0 This issues in consultation with Freight Marketing Branch and with the concurrence of Finance Directorate of Ministry of Railways.
