
विषय/Sub: Liberalised Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD)

2.) JD,TC/Railway Board's letter No.TCR/1078/2019/2/TEFD/ 3318144 dated 07.08.2024 (Corrigendum No.2 to Rates Circular No.9 of 2024)

- 1.0 In terms of Board's letter under reference, guidelines were issued on the above cited subject. These instructions are valid till 31.03.2025.
- 2.0 The matter has been reviewed. Sanction of the Competent Authority is hereby accorded for addition and deletion of certain traditional empty flow streams in the policy, which are annexed with this circular.
- 3.0 All other details of the policy will remain unchanged.
- 4.0 These instructions will come into force w.e.f. 12.08.2024 and will remain valid till 31.03.2025.
- 5.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate in the Ministry of Railways.
