Corrigendum No 04 to Corrigendum No.97 to Rates Master Circular /PCC/CC+8 etc/2020/0

1. In terms of Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0, Permissible Carrying Capacity of various wagons have been notified up to one decimal place.

2. The same has been reviewed and the Competent Authority has decided to revise PCC of BOXNHL and BOXNHL25T wagon over different routes as 64.0 tonnes (for Steel Coils only).

3. Accordingly, S. No.9 &13 in Annexure – IA (A-Open Wagons) of Corrigendum No.97 to RMC on PCC/CC+8etc. /2020/0 shall be revised as under:



5. All other terms and conditions of Rates Master Circulars referred above and Corrigenda thereto shall remain the same.



6. This issues in consultation with Traffic Transportation, Mechanical Engineering Directorates and with the concurrence of Finance Directorate of the Ministry of Railways.
