विषय/Sub: Charging of two-wheelers when loaded in NMGHS wagons.

संदर्भ/Ref: 1.) JD,TC(R)/Railway Board's letter No.TCR/1394/2021/NMGH/3377973/3332914 dated 04.09.2024 (Corrigendum No.8 to Rates Circular No.32 of 2021)

2.) Rates circular No.32 of 2021 and Corrigendum thereto.

- 1.0 In terms of Corrigendum No.2 to Rates Circular No.32 of 2021, it was inter-alia communicated that when NMGHS wagons is loaded with two-wheeler traffic, charging will be done at 1.5 times of the freight applicable for NMG wagons.
- 2.0 The matter has been reviewed. It has been decided that the charging of two-wheelers traffic when loaded in NMGHS wagon in double stack will continue to be done at 1.5 times of the freight rate applicable for NMG wagon. However, in case two-wheelers traffic is loaded in NMGHS wagons in single stack, then the charging will be done at par with NMG wagons.
- 3.0 Zonal Railway shall verify that double stack loading of two-wheelers in NMGHS wagons is not possible and therefore single stack loading has been done. A certificate to this effect will be issued by concerned station master/goods clerk.
- 4.0 All other details of the circular under reference will remain unchanged.
- 5.0 These instructions will come into force with effect from 15.09.2024 and will remain valid till further advice.
- 6.0 This issues in consultation with Traffic Transportation and Freight Marketing Directorates and with the concurrence of Finance Directorate in the Ministry of Railways.
