Agreement is executed with M/s JSW Steel limited under Liberalized Special Freight Train Operators Scheme. (LSFTO) on 13.10.2021 for 16 BFNW rakes and on 16.12.2022 for 12 BFNW rakes.

- A separate notification will be issued for BMCO after commissioning of OHE inside BMCO siding.
- Wharf shall be released immediately after unloading at CJ/SR, since delayed clearance of wharf affects the release of further rakes.

Other terms and conditions mentioned in Railway Board letter dated 19.01.2021 & 18.05.2022 shall remain unchanged.
