

1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
2. In terms of reference (i) above, General Managers are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
3. Eastern Railway has forwarded proposal, with due approval of General Manager, to include the following routes of Eastern Railway in the list of already identified CC+8 routes:-
  - i. Jasidih Jn.(JSME)-Baidyanathdham (BDME) subject to maximum permissible speed of (30kmph up to 0.0-0.71km & 50kmph from 0.71km to 6.52km).
  - ii. Howrah(HWH)-Bally (BLY) UP/DN Chord & UP/DN Main Line subject to maximum permissible speed of 60 kmph.
  - iii. Liluah(LLH)-Belurmah (BRMH) subject to maximum permissible speed of 30 kmph
4. Sanction of the Competent Authority is hereby accorded to include the above referred routes of Eastern Railway in the list of already identified CC+8 routes subject to maximum permissible speed as mentioned above. This speed limit can be reviewed by the zonal railway and may be revised as and when required.
5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified,
6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
7. These instructions shall come into effect from 17.10.2024 and shall remain valid till further advice.
8. This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.
