- 4. Accordingly Annexure-IV of Rates Master Circular under reference (iii) above shall be modified.
- 5. The speed limit mentioned above can be reviewed by the Zonal Railway and may be revised as and when required.
- 6. These instructions shall come into effect from 14.11.2024 and shall remain valid till further advice.
- 7. This issues in consultation with Traffic Transportation Directorate and with the concurrence of the Finance Directorate of Ministry of Railways.
