(Freight marketing Circular No. 20 of 2024)



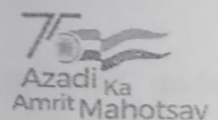
