Addendum No.08 of Rates Master Circular/Weighment/2019/0

Please refer to Board's circular under reference stipulating guidelines regarding Dispensation from mandatory weighment of wagon/rake loaded with Nut Coke, by inserting additional Para 3.4.1 in Rates Master Circular/ Weighment /2019/0, as under:


"3.4.1: Dispensation from mandatory weighment of wagon/rake loaded with Nut Coke may be permitted with a proviso that at least 5% of rakes should be subjected to weighment (where sample rake to be selected should be completely random) and as per the guidelines prescribed for Petroleum/Metallurgical Coke vide Para 3.4".

These guidelines are valid upto 14.12.2024.



The matter has been reviewed and it has been decided to extend the currency of the above-mentioned guidelines beyond 14.12.2024, for a further period of one year ie upto 14.12.2025.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railway.
