विषय/Sub: Permissible Carrying Capacity (PCC) of BOXNHL wagon for loading of steel coils.

Corrigendum No 05 to Corrigendum No.97 to Rates Master Circular /PCC/CC+8 etc/2020/0


1. In terms of Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0, Permissible Carrying Capacity of various wagons have been notified up to one decimal place.
- 1.1. Further, in terms of corrigendum No 04 to Corrigendum No 97. PCC of BOXNHL and BOXNHL 25T wagons over different routes have been notified' as 64 tonnes for loading of Steel Coils only.
2. The above has been reviewed and the Competent Authority has decided to revise PCC of BOXNHL and 25T wagons over different routes as 56 tonnes or actual weight, whichever is higher, subject to maximum of 64 tonnes for steel Coils only.
3. Accordingly, S No. 9 &13 of Annexure -IA (A-Open Wagons) on Page 4 of the Corrigendum No 97 to RMC on PCC/CC+8 etc./2020/0 shall be revised as under:

3. For loading in above wagons, overriding priority shall be given to the high yielding commodities over steel coils at the reduced PCC at the same terminals.
4. The above shall be effective from 24.12.2024 and shall remain in operation till further advice.
5. All other terms and conditions of Rates Master Circular referred above and Corrigenda thereto shall remain the same.

6. This issues in consultation with Traffic Transportation, Mechanical (Freight) and with the concurrence of Finance Directorate of the Ministry of Railways.
