- The matter of applicability of terminal charge on automobile traffic was reviewed from time to time and the last exemption up to 31.12.2024 was notified in terms of Corrigendum No. 04 to Rates Circular No. 14 of 2019 dated 26.12.2023.
- 3. The matter has been further reviewed and it has been decided by the Competent Authority to continue the validity of the exemption beyond 31.12.2024 till 30.06.2025.
