1. In terms of Corrigendum No.5 to Rates Circular No. 16 of 2020, the instructions for concession to short lead traffic were issued which is valid till 31.12.2024.

- The matter has been reviewed and the Competent Authority has decided to extend the validity of the above instructions beyond 31.12.2024 and the same will be in force till 31.12.2025.
- 3. All other terms and conditions laid down in above referred Rates Circular shall continue to apply unchanged.
- 4. All Zonal Railways please keep a watch on the subject traffic and arrange to provide comments at the end of each financial year enabling this office to review the subject concession.
- 5. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
