## Corrigendum No 128 to Rates Master Circular on PCC/CC+8 etc/2020/0

1. Reference above, Concessional Permissible Carrying Capacity (PCC) and Loading Tolerance on various routes for "BOST" type of wagons (at S.NO.26 in Annexure-IA under category A.OPEN WAGONS) when used for carrying "Steel Pipes is as under:
