Please refer to para 6.0 of Chapter-I of the circular under reference(i) stipulating guidelines regarding levy of Stabling Charge for the detention of privately owned stock, including container wagons, at railway premises.


Presently, rate of Stabling Charge is ₹650/- per wagon per day or part of a day and is valid upto 30.04.2025 as per Board's letter under reference(ii).

The matter has been reviewed and it has been decided to revise the rate of Stabling Charge from \*650/- to ₹700/- per wagon per day or part of a day in case of all privately owned wagons including wagons owned by container operator. The revised rate will be effective from 01.05.2025 and will remain valid for a period of one year.

This issues in consultation with Freight Marketing Branch & Traffic Transportation Dte and with the concurrence of Finance Dte. of Ministry of Railways.
