Engagement of Station Ticket Booking Agents (STBA) on commission basis at 'NSG 6' category stations in various stations over Mysuru Division for issue of unreserved tickets through computerized Unreserved Ticketing System (UTS). The list of stations is furnished in the following pages.

A maximum of one STBA at 'NSG 6' category stations who will be required to disburse unreserved tickets throughout the day (24 hrs).

### **Period of Contract**

STBA shall function from the existing counter at station. Initial period of contract will be for three years. On selection an agreement will have to be executed by STBA with the Railway.

### **Commission payable**

Out of the applicants fulfilling the eligibility conditions, the candidate who opts for the least commission on the turnover of above Rs. One lakh slab will be selected for appointment. Calculation of commission will be done on monthly basis. In case more than one applicant quotes the same rate, the selection will be based on the draw of lots in a transparent manner in public. No applicant should quote **Negative Percentage.**

**IN CASE AN APPLICANT QUOTES SUB-ZERO COMMISSION IN SLAB-3, HIS APPLICATION WOULD BE SUMMARILY REJECTED AS PER RAILWAY BOARD LETTER NO.2023/TG-I/20/STBA COMMISSION DATED: 18-08-2023.**

The basis of selection of STBA shall be the lowest commission quoted in the slab 3 of more than Rs.1,00,000/- turnover. The commission will be paid on net sale and in the case of concessional tickets it shall be on the actual fare collected by the Railway. The percentage of commission should be written in figures and words. If there is any discrepancy in the rate quoted, the rate written in words will be taken as correct.

The commission will be calculated on monthly basis as is being done for Halt agents and as per IRCM Vol. II para 2425 item No.28. Commission to STBAs shall be paid from the Station Earnings. The commission shall be paid on the amount credited to Railway's account. In case of concessional tickets, the commission shall be calculated on the actual fare collected by the railways.

## **Qualification**

- (a) The applicant should be a resident of the local District in which the NSG 6 category stations is located where STBA is proposed to be engaged. Relaxation in this condition can however, be given by Sr.DCM/DCM, in case no suitable candidate of local District is eligible to be engaged as STBA.
- (b) The applicant should not be under 18 years of age and should have passed at least Class-X exam.
- (c) The selected applicant will also have to produce a certificate from the police station serving his/her locality that he/she has not criminal record and no criminal case is pending against him/her.
- (d) STBA and his/her nominated agent should not be ex-Railway staff that has been removed or dismissed from service on the grounds of doubtful integrity.

## **Documents to be submitted**

The selected applicant will have to produce a certificate from the police station serving his/her locality that he/she has no criminal record and no criminal case is pending against him/her. One applicant can be engaged as STBA at only one station. While furnishing bid/application, applicant should give a declaration that he/she has not been appointed at any other station. False declaration will entail rejection of the application summarily and action taken against such person/s in accordance with law.

## **Payment of deposits**

The applicant should submit their application along with an earnest money of Rs.2,000/- for NSG-6 and Rs.5,000/- for NSG-5 category stations along with a passport size photograph. Selected applicants shall deposit a refundable security deposit of Rs.10,000/- for NSG-6 and Rs.25,000/- for NSG-5 category stations & bank guarantee of Rs. 20,000/- or FDR of any Nationalized Bank drawn in the name of Sr. Divisional Finance Manager, South Western Railway, Mysuru payable at Mysuru. On completion/termination of contract, pending dues will be adjusted from the security deposit and balance will be refunded to STBA. The STBA who has been appointed has to remit the Security Deposit & Bank Guarantee within 14 days from the date of receipt of awarding letter and start disbursing the tickets at the station awarded duly entering in to the agreement.

## **Procedures**

- (1) The cost of hardware and software (including maintenance), electricity and hiring of channel will be borne by the Railways. The space will also be provided by the Railways free of cost.

- (2) STBA, however, if he/she so desires, may nominate additional persons for sale of tickets. Additional number of persons which can be nominated shall be decided by Sr. DCM/DCM based upon the quantum of ticket sale at the station. Provision for the same may be made in the standard agreement, with prior approval of the Railway authorities subject to fulfillment of prescribed conditions mentioned in para-4 above.
- (3) STBA shall not sublet/assign or transfer the rights or obligations arising out of the agreement. In case of death of agent, his/her legal heir(s) will be allowed to act as the STBA for the unexpired period of the agreement by the competent authority, subject to para-4 above.
- (4) Both the STBA and the additional person, if any, nominated by him to sell tickets shall be issued photo identity cards by the concerned Sr.DCM/DCM and their name(s) shall also be displayed on a notice Board at the station premises.
- (5) The STBA operator shall be allowed to sell all types of non-concessional unreserved tickets issued through UTS including platform tickets and season tickets, on cash basis only. Zonal Railways can also authorize payment through POS/Digital modes at such locations keeping in view the local conditions. Renewal of season tickets and issue of senior citizen concessional tickets shall also be permitted. All other concessional tickets requiring documentary proof before issue of ticket can also be issued by STBA only when endorsed and permitted by the SM/ASM/Supervisory Booking clerks or Reservation Supervisor concerned, which shall be done prior to the sale of such concessional tickets.
- (6) The facility of 'NI' (Non-issued) ticket will be available to the STBA only when authorized/endorsed by the concerned SM/ASM/Supervisory Booking clerk or Reservation Supervisor.
- (7) Cancellation of ticket: The facility of cancellation of ticket may be extended to STBA only when authorized/endorsed by concerned Station Master/Assistant Station Master/Supervisory Booking clerk or Reservation Supervisor beforehand.
- (8) Money receipts, TTE Cash, Parcel cash etc. Can be remitted at the STBA counters only when authorized/endorsed by concerned Station Master/Assistant Station Master/Supervisory Booking clerk or Reservation Supervisor beforehand. However, the revenue so received shall not be accounted for in the monthly turnover of the station, for the purpose of calculating the commission for STBA.
- (9) STBA shall deposit the cash collected through sale of tickets, to the concerned Station Master/Assistant Station Master/Supervisory Booking clerk or Reservation Supervisor of the station on duty on 8 hour shift basis as prevalent on that station.

- (10) All concession orders should be handed over to the SM/ASM/Supervisory Booking clerk or Reservation Supervisor along with cash and cancelled/NI tickets. Failure of the STBA to do so shall result in the collection difference of fare to be recovered for the STBA.
- (11) If the ticketing activity stops due to non-availability of STBA or due to his/her negligence resulting in non-functioning of equipment, penalty equal to the average daily turnover from sale of UTS tickets from that location, subject to a minimum of Rs.2000/- per day shall be imposed. Penalty up to Rs. 500/- may be imposed against established public complaints regarding the functioning of STBA.
- (12) The railway officer in charge of the station i.e. Station Master/Assistant Station Master/Supervisory Booking clerk or Reservation Supervisor shall be responsible for the safe custody of the ticket rolls and it shall be his duty to handover/takeover the ticket rolls daily from the STBA. Proper record of ticket rolls issued to the STBA shall be maintained at the stations.
- (13) Shift summary and details of daily summary of transaction handled by STBA shall be extracted through UTS and the STBA shall deposit the cash accordingly to the Station Master/Assistant Station Master/Supervisory Booking clerk or Reservation Supervisor at the end of the shift.
- (14) A consolidated statement of ticket rolls supplied and details of tickets sold by STBA shall be submitted by Station Master/Assistant Station Master/Supervisory Booking clerk or Reservation Supervisor or any other nominated officer to DCM/Sr. DCM every month.
- (15) Zonal Railway shall have powers to prescribe working guidelines within the framework of this scheme. The Railway shall also frame an agreement to be signed with STBA based on these policy guidelines and as per provisions of Chapter-X of Indian Contract Act, 1872 and in consultation with the concerned Departments on the Railways.
- (16) In case STBA expressed inability to operate the counter(s) after his/her selection by Zonal Railways, the security deposit furnished by him/her shall be forfeited and deposited in Railway accounts as per procedure.

The DRM, ADRM, Sr.DCM or any other authorized representative shall have free access to inspect the working of STBA at any time of the day.

Cash as per the summary extracted through UTS shall be deposited to the on duty SM/ASM without any shortage. Any amount found excess in the counter shall also be deposited along with transaction cash and no shortage will be accepted whatsoever be the reason.

The approximate earnings at the stations listed below are only indicative in nature. The actual amount may vary from what is advertised.

**Period of engagement:**

Initially STBA shall be engaged for a period of 3 years. An agreement shall be executed by STBA with Sr.DCM or DCM. Fresh application shall be floated well before the expiry of three years. In case of delay in finalization of tender, existing agreement may be extended for 6 months or till finalization of new agreement as per this scheme, whichever is earlier. However, such extension shall not exceed three years.

**Termination:**

Each side can terminate the agreement without assigning reasons by giving a notice of 30 days. However, in case of fraud/criminal case, Railway shall be at liberty to terminate the contract without giving any prior notice.

**Disabling clause:**

Engaging an individual as STBA shall not confer any right and/or claim whatsoever on the person to seek employment on Railways. No benefits viz. absorption in Railway service, regularization of service, bonus, railway pass facilities etc. shall accrue to the STBA or his/her legal heirs. No claim in this regard shall be entertained. STBA shall keep Railways free from any liabilities in present or future. Suitable clause to this effect shall be incorporated in the Agreement.

**Arbitration:**

To resolve any dispute or claim of any kind or nature arising under or in connection with this agreement between the parties, the standard arbitration clause may be incorporated in the Agreement.

4. I agree that I will not withdraw the offer before the Railway Administration accepts or rejects the same or before ninety (90) days from the date of opening of the tender, whichever is earlier. In the event of my withdrawing the offer the Earnest Money Deposit shall be liable to be forfeited by the Railway Administration.
5. I shall not reassign, sublet or transfer the license, whether in full or part thereof.
6. I have carefully noted the terms and conditions of the contract and inspected the place where I have to carry out my responsibility.
7. I take all risk and responsibility for any errors and omissions that may arise from any discrepancy from misunderstanding or misconception of the terms of the contract agreement.
8. I agree that it shall be lawful for the Railway to terminate the contract forthwith without notice or without being liable for any loss or damage whatsoever and to forfeit the entire EMD and security deposit amount in case the declaration is found false or any of the conditions of the agreement is found to be violated by me.
9. I agree to replace or repair the damages that may be caused to the Railway property during the course of execution of the contractual work and inform the Railway of the same.
10. The Earnest Money Deposit, SD and BG shall be forfeited and appropriated by the Railway Administration in case of failure to comply with any of these conditions not as a penalty but as ascertained liquidated damages without prejudice to any right of the Railway Administration to claim damages from me for breach of contract.

## **INSTRUCTIONS TO APPLICANTS REGARDING APPLICATION FORMS DOWNLOADED FROM INTERNET**

1. Application shall be down loaded from the internet and printout is to be taken on A4 size paper and details are to be entered by the applicant at the specified columns in the document. It is advisable that the down loaded document to be printed through laser/inkjet printer only. Submission of Xerox or photocopy of document is not acceptable.
2. This downloaded document (in full) is required to be submitted along with the various documents as per the conditions in a sealed cover duly superscripting with the name of the work, Notice No. and date, submission of form downloaded from the internet etc and the same should be dropped in the box kept in the Office of Sr. Divisional Commercial Manager, S.W. Railway, Mysuru -570 001 before the date and time stipulated in the document.
3. The cost of document as indicated in the tender document will have to be deposited by the applicant in the form of Nationalized Banks' demand draft payable in favour of **Sr. Divisional Finance Manager, South Western Railway**, Mysuru - 570 001 along with the document. This should be enclosed as a separate Demand Draft. A single demand draft for the cost of application form and Earnest Money Deposit will not be accepted. Application not accompanied by the above demand draft towards the cost of the application document will be summarily rejected.
4. The earnest money deposit required for this as stipulated in the document also to be submitted separately along with the document.
5. Applicants are advised to download the documents well in advance and submit the same before the stipulated time. It is the responsibility of the applicant to check for any corrections or any modifications published subsequently in website and the same shall be taken into account while submitting the application.. Applicant shall down load corrigendum (if any), print it out, sign and attach it with the main tender document. Document not accompanied by the published corrigendum/s is/are liable to be rejected. The Railway will not be responsible for any postal delays and delay in downloading of document from the internet.
6. The applicants may please note that the rate should be written in figures and words in the application booklet in black or blue ball point pen only. Each page of the document should be signed by the applicant.
7. Applicants are free to download the document at their own risk and cost, for the purpose of perusal as well as for using the same as the document for submitting the offer, Master copy of the document is available in the Office of Sr. Divisional Commercial Manager, S.W. Railway, Mysuru -570 001. After award of work, an agreement will be drawn, which shall be executed by the successful applicants and this agreement will be prepared based on the above said master copy of document and not based on the document

8. 17. If the applicant withdraws his/her/their offer before the Railway accepts or rejects the same before the finalization of the tender or ninety (90) days from the date of opening of tender, whichever is earlier, the Earnest Money Deposit will be forfeited by the Railway as ascertained liquidated damages.

**GENERAL CONDITIONS OF THE CONTRACT FOR ENGAGEMENT AS STBA  
OVER MYSURU DIVISION**

1. The General Conditions of Contract (GCC) of South Western Railway as amended from time to time shall be applicable to this contract. In the event of conflict with the specific terms and conditions of the contract, the same shall prevail upon the General Conditions of the Contract. The term defined in clause 1(1)(c) of the GCC shall in the context of the present contract mean the Officer in charge of the Commercial Department of South Western Railway and shall also include Chief Commercial Manager (PB) and Chief Commercial Manager (FM). The terms defined in 1(1)(e) of the GCC shall in the context of the present contract mean Senior Divisional Commercial Manager, South Western Railway and include Divisional Commercial Manager, South Western Railway.
2. The Contractor shall not use the name of the Railway in any manner either for credit arrangement or otherwise and it is agreed that the Railway shall not in any way be responsible for the debts, liabilities or obligations of the Contractor.
3. The Contractor shall be responsible for the diligent performance of the duties and for the conduct and behavior.
4. On engagement as STBA the applicant should report to duties for the issuance of tickets well in time, neatly dressed and should be always in a well behaved manner, deal with the public and not to give any room for any complaints from the controlling supervisor or public. In the event of any lapses reported the Railway Administration reserves the right to terminate the engagement without any prior notice for not abiding the conditions of the engagement including forfeiture of the deposits which includes Security Deposit and Bank Guarantee and claim any dues to be paid to the Railway Administration by way of notice or through legal action.
5. The successful applicant on engagement as STBA should discharge the duties of ticketing assigned to him and abide by the instructions of the station managers/supervisors under whom he/she is working. In the event of causing hindrance in functioning day to day duties or causing unwanted act of behavior either with public or the supervisor resulting in undue hitch to the supervisor and the public due to the act of unbecoming an STBA, on such instances reported by the supervisor or any complaint the Railway Administration reserves the right to terminate the engagement without any prior notice and take all remedial actions including forfeiture of the deposits includes Security Deposit and Bank Guarantee and claim any dues to be paid to the Railway Administration by way of notice or through legal action from the applicant.
6. The applicant shall have no right to claim for refund or re-engagement and will be further barred from participating in STBA tenders in the Railways.

7. Without any prejudice to the Railways other rights, the Railway will be entitled to deduct from the commission, any shortage or other amounts payable, charges and expenses incurred or made by the Railway due to any act of omission by the STBA. The Railway shall not be responsible for death, injury or accident to the STBA, which may arise out of and in course of their duty in the Railway premises. The STBA shall be fully responsible for the acts of omissions and shall indemnify and keep harmless the Railway from and against any loss and expenses thereby caused.
8. The STBA shall not indulge in overcharging or undercharging in the sale of tickets or any other fraudulent activities. Any such activity of indulgence or fraud will result in termination of the contract with its consequences.
9. In the event of the contract being terminated because of unsatisfactory performance and breach of any of the terms and conditions, it shall be lawful for the Administration to forfeit the entire Bank guarantee.
10. Any legal disputes will be within the jurisdiction of District Court of Mysore.

Subject to as otherwise provided in this contract, all notices given on behalf of the President of the Union of India and all other actions to have taken on his/her behalf may be given or taken on this behalf by the Senior Divisional Commercial Manager, South Western Railway, Mysuru Division, Mysuru.

Any notice served by the Administration shall be deemed to have been served as if it is dispatched to the address of the Contractor given in the agreement by registered post with acknowledgement due.

This contract may be terminated by either party by giving to the other, 10 days notice in writing of its intention to terminate this contract.

**FORCE MAJEURE:**

Neither party shall be liable nor deemed to be in default for any delay or failure in performance under this Agreement or other interruption in the discharge of its responsibility, either directly or indirectly, from acts of God, civil or military authority, acts of public enemy, war, accidents, fires, explosions, earthquakes, floods, failure of transportation, machinery or supplies, vandalism, strikes or other work interruptions by employees or any similar or dissimilar cause beyond reasonable control of either party.
