(Corrigendum No. 06 to Rates Circular No.14 of 2019)

1. Reference above, Para 3 of Rates Circular No. 14 of 2019 stipulated exemption from levy of terminal charge on automobile traffic.
2. The matter of applicability of terminal charge on automobile traffic was reviewed from time to time and the last exemption up to 30.06.2025 was notified in terms of Corrigendum No. 05 to Rates Circular No. 14 of 2019 dated 31.12.2024.
3. The matter has been further reviewed and it has been decided by the Competent Authority to continue the validity of the exemption beyond 30.06.2025 till further advice.
4. This issues in consultation with Traffic Transportation Directorates and with the concurrence of Finance Directorate of the Ministry of Railways.
