विषय/Sub: Permissible Carrying Capacity (PCC) of BLCS (A-car & B-car) wagon.

(ii) Railway Board letter No. TCR/1394/2021/PCC/Container/3494548 dt: 11.07.2025

(Corrigendum No.10 to Corrigendum No.97 to Rates Master Circular /PCC/ CC+ 8etc./2020/0)

1. In terms of Corrigendum No. 07 to Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0, Permissible Carrying Capacity of BLCS (Car A & Car B) wagon in Annexure IC of Corrigendum No. 97 have been notified up to one decimal place.
2. The matter has been reviewed and the Competent Authority has decided to revise the PCC and chargeable weight per container of BLCS wagons.
- 2.1 Accordingly, S.No. 10 and 11 in Annexure IC of the Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0 shall be revised as under:
