1. In terms of Rates Circular no. 15 of 2024, classification of Soda Ash, Soda Ash Dense, Soda Ash Light has been reduced as Class-120 w.e.f. 16.08.2024 up to 15.08.2025.
2. The issue has been examined and the Competent Authority have decided to extend the validity of reduced classification of Soda Ash, Soda Ash Dense, Soda Ash Light beyond 15.08.2025 up to 15.08.2026.
